INSTRUCTIONS FOR USE

When and where to use:

Py Bug Killer RTU is a broad spectrum insecticide for the control of insect pests such as aphids and caterpillars on roses and a range of garden vegetables.

Also for use against beetles on specified vegetables. Do not apply when bees are actively foraging (use early in the morning or late in the evening).

How to use:

Spray plants thoroughly, including the underside of the leaves.

Cabbage, broccoli, cauliflower and potato	1L product to treat 20 m ²	2 per crop	10 days	7 days before harvest

Protection during/in use
