

USE PESTICIDES SAFELY/READ THE LABEL

A ready to use soluble aqueous formulation containing 3.6 g/l triclopyr present as the triethylammonium salt

INSTRUCTIONS FOR USE

WHEN TO USE

Ready to Use SBK Brushwood Killer controls brambles, thistles, nettles, docks, tough weeds, woody weeds and hardwood saplings in grassland and non-crop areas. Apply from May to October (June to August for woody weeds) when soil is moist and the weeds are in active growth. Ready to Use SBK Brushwood Killer targets weeds not grass but may cause some damage to lawns and fine turf. A repeat treatment may be applied after six weeks. Allow at least six weeks between application and replanting. Apply a maximum of two treatments per season.

WHERE TO USE

Use in grassland and non-crop areas, Do not apply during drought or in freezing conditions, when rain is imminent or the weeds are wet. Do not apply in windy weather and avoid drift onto broadleaved plants outside the target area, Keep off cultivated plants. Direct spray away from ponds and other surface water bodies. Keep grazing animals out of treated areas until foliage of any poisonous weeds like Ragwort have died down and become unpalatable.

Children and pets can be allowed on treated areas after spray has dried.

HOW TO USE

Shake well before use. Adjust the nozzle to give the required spray pattern and holding approximately 30cm (12 inches) above the target weed, pump the trigger firmly to thoroughly cover weeds without run-off. One trigger stroke (0,7ml) is sufficient to cover a 15cm (6") diameter weed. Avoid production of a fine spray that can drift onto neighbouring plants.
