INSTRUCTIONS FOR USE

FOR USE AS A HOME GARDEN SLUG KILLER

WHEN TO USE:

At the first sign of plant damage use as directed during late evening or early morning when slugs are most active.

WHERE AND HOW TO USE:

Evenly scatter the pellets to moist, bare soil around all edible and non-edible plants (eg hostas, bedding plants, strawberries, lettuce and cabbages, etc) at 5g per square metre. Repeat treatment may be necessary to maintain control to a maximum of 4 treatments at 5g per square metre, per crop.

The pellets swell, absorbing water from moist soil, becoming more attractive to slugs. After consuming the pellets, slugs cease to feed, moving away to die without leaving a trace.
