

A ready for use liquid bait containing 0.081% w/w spinosad.

Nippon Ant Bait is highly attractive to black 'worker' ants which collect the bait to feed the queen and other ants in the nest. Clean & easy to use – control ants without mess or trace.

DIRECTIONS FOR USE

Clear up other readily available foodstuffs. Remove bait station from pack and snap off the 3 lugs to open access holes to the bait. Place one or two bait stations on a flat surface, preferably in late evening, by the nest or ant run. Replace the bait station if exhausted. Ant activity will normally cease in 7 to 10 days. Do not disturb feeding ants, which pass Nippon on to the entire colony. Ants are only controlled if Nippon is the main food source.

Keep in a safe place. Do not open bait box. Do not use where food, feed or water could become contaminated. There should be an interval of at least 7 days between successive 28-day treatment campaigns. When used outdoors use at most 2 bait stations. Effective for 1 month.

Do not contaminate surface water or drains with chemicals or used container. Do not re-use empty containers. Store in original container. Shelf life up to 2 years.

Harmful to aquatic life with long lasting effects.

Keep out of reach of children. Avoid release to the environment. Dispose of contents/container to a household waste recycling centre as hazardous waste except for empty containers which can be disposed of by recycling. Contact your local council for details.
